With great sadness the Hammock Dunes Owners' Association announces that Ms. Doris Meyer passed away on Sunday, March 29, 2015. Ms. Meyer touched the lives of many Hammock Dunes residents and her obituary is below:

Doris Catherine Meyer (McKenna) died March 29, 2015 at her home in Kirkwood after a long hard struggle with cancer. She was preceded in death by the Love of her Life, husband Stuart F. Meyer. Living most of her life in St. Louis, Doris moved to Palm Coast, FL after Stuart's retirement in 1995, where the two of them would pursue a life of golf and establish true friendships with those of the same interests. They accomplished their goals and more. Palm Coast was a community where they were accepted with open arms and truly considered home.

During his battle with cancer, Stuart shared a

vision with his oncologist to establish a much needed hospice house in Flagler County. In 2001 Stuart's death inspired Doris and some close friends to raise the funding for an end of life facility in Stuart's name. It took a lot of time and dedication, but Doris and this team of friends brought Stuart's dream to life. The Stuart F. Meyer Hospice House opened it's doors on April 12, 2007 in Palm Coast, FL. Doris's legacy and Stuart's memory will live on within this house.

Doris had many recognitions in Florida, but the one she treasured the most was the 2005 Humanitarian of the Year Award presented by the Florida Hospital Memorial Foundation.

Doris was a dedicated loving mother of 5 children: Catherine (Jerry) Jones, Barb Ashley-Campbell, Elizabeth (Bruce) Carter, Russell (Ann) Meyer, Patricia (Neil) Norton. Preceded in death by granddaughter Kelly Ann Jones. Dear grandmother of eight, grandmother-in-law of one and great grandmother of two. Sister of Joseph McKenna and the late James McKenna. Preceded in death by both parents Sylvester J. McKenna and Doris McKenna. Best friends of Ann and Jerry Tranzow and Pat and Elmer Stainbrook, friends of many and loved by all.
