# **Communications & Community Relations**

ON MOTION BY Jef Amsbaugh, seconded by Bruce Aiello with all in favor, the Board voted on whether to approve a rear setback variance similar to the adjacent neighbor for 8 Riviera subject to DRC and Hammock Dunes Club approval. Motion carries.



## **Financial Committee**

Mr. Aiello provided the Board with a financial update. Mr. Aiello reported that the HDOA was \$28,000 over budget for the month of May.

## **Declarant & Development Committee**

Mr. Gill provided the Board with a DDC update. Mr. Gill reported on the Hurricane Irma FEMA binding arbitration that took place on June 4<sup>th</sup> and June 5<sup>th</sup> in Washington D.C. Mr. Gill, Mr. Dumke, and Mr. David Eckert attended on behalf of the HDOA. The panel ruled in favor of FEMA because Hammock Dunes is not a qualifying entity. Subject to the panel's ruling, the Board discussed dropping the lawsuit in regards to Hurricane Matthew.

ON MOTION BY Bruce Aiello, seconded by Marge Rooyakkers with all in favor, the Board approved dropping the Hurricane Matthew lawsuit and asking FEMA to assist with classification of maintenance responsibilities to qualify as a designated facility.
