Communications & Community Relations

Hurricane Dorian Status Update

Security & Emergency Response Committee

Ms. Rooyakkers brought up the issue about GPS coordinates/mapping and issues with the condos and Flagler County emergency services. The Committee suggestion is to install some directional signage specifically around the Camino del Mar rotary circle. Ms. Rooyakkers asked the Board to review the request the next time their around the circle.

"Dwelling Live," the new access control hardware will go live January/February 2020.

Design Review Committee

191 Island Estates Parkway - Roof Tile Variance Request

Mr. Amsbaugh confirmed several approvals were provided as part of the normal meeting; however the Committee did have a separate DRC meeting to review a composite slate roof tile ("Da Vinci" Slate Grey) that has been submitted for review. The DRC voted to approve the variance.

The HDOA had discussion about the roof tile; specifically confirming any approval is without precedence and strictly a test case that may or may not be considered for future homes.

ON MOTION BY Jef Amsbaugh, seconded by Beth Thomas, with all in favor, the Board voted on whether to approve "Da Vinci" slate grey as a one-time approval for 191 Island Estates Parkway without precedence for future roof tile review. Motion carries.

Financial Committee

Mr. Aiello reported on the August 31st financials and reviewed the neighborhoods. The HDOA continues to run a deficit; however many items will be charged to reserve expenses. Mr. Aiello confirmed the 1st draft of the Reserve Study report has been issued and appears to be favorable. The final draft results will be communicated at the Budget Workshop meeting that is scheduled for Monday, October 28th at 10am.

Mr. Aiello reminded all Committee chairs to submit their budgets to him for the Finance Committee to review.

Declarant & Development Committee

Mr. Aiello confirmed the Hammock Dunes community made it thru Hurricane Dorian with minimal issues. The dune walkovers are in good shape. Approximately 5-15% of sacrificial dune sand has been lost; however Mr. Houk is contacting Flagler County to request assistance pushing existing beach sand at low tide to the protective berm since the permits and easement agreements are still in place. Mr. Aiello confirmed the expectation for Flagler County to address the dunes will be after November 1, 2019; however there is no obligation for them to assist with this project.

Flagler County still owes the HDOA a final ASBUILT survey for the dune restoration project as well as the final true-up for the financials.

There is no new info about Renaissance to share.
