### Message from the President

As the newly appointed President of the HDOA, I want to thank George DeGovanni for his tireless and strategic services as HDOA President these past 6 years. George resigned last month, which he had been planning to do for over

a year. Fortunately he has agreed to continue his participation in key HDOA committees addressing post-Matthew recovery and land development efforts.

My primary objectives for the next couple of years are to:

- · Continue to provide basic services (maintenance, streets, security, etc.) at a premium service level.
- · Continue to aggressively pursue post-Matthew recovery activities, including obtaining FEMA reimbursement and completing repairs to the dunes and walkovers. On July 8, the Florida Department of Emergency Management, after meeting with us and reviewing our FEMA appeal, as part of the FEMA appeal process, sided with us and recommended that FEMA re-establish our eligibility for

FEMA funding. We are awaiting FEMA's decision. We are working with the offices of Senator Nelson and Representative DeSantis to expedite our FEMA efforts. We are also working closely with the County regarding its dune restoration efforts (ideally, our Phase 2).

- · Continue efforts to enhance property values and buildout of the undeveloped lots in the HDOA. Those efforts include working with property owners, the development and realty communities, the Design Review Committee and the Declarant and Development Committee.
- · Continue to work cooperatively with Hammock Dunes Club.

### **HDOA Committee Reports**



**Finance**by Bruce Aiello

The Dune Walkover(s) repair has been funded from neighborhood, condo, Club and HDOA reserves. Our FEMA dunes restoration reimbursements request was initially denied. However, our first appeal has been filed and initial indications are for a more favorable response. For the first six months of 2017, we are running slightly overbudget, causing several projects to be rescheduled the next quarter. The conservative forecast is to be within budget by October pending no new disasters.



**Design Review**by Cosmo DiPerna

The HDOA has approved five updated Design Review Manuals—a two year effort. The documents may be found on the Hammock Dunes website and include Granada Estates, Villas neighborhoods, Grand Mer, Island Estates and Playa del Sur/Carino la Mer.

Dave Mancino, our architectural consultant for 20 years, will be resigning at the end of September. He has reviewed many hundreds of homes and villas over the period, and we will very much miss his advice and support. A team has been established to find a replacement.

Since the last issue of *Inside The Gates*, approval has been granted for a new oceanfront home along Calle del Sur, two Island Estates homes, two major additions in Island Estates as well as one in Granada Estates. Other approvals include two coquina walls, one pool, two new roofs and many landscape and other minor changes.

The Committee meets in the afternoon on the second Monday of every month. Members include consultants Bob Dickinson and Dave Mancino and community members Ada Abernathy, Cosmo DiPerna, Julie Gamble, Julie Karner, Mike Machin and Donna Trindle. Carsten Georg from Southern States Management Group provides administrative support.



Declarant and Development

The Declarant and Development Committee (DDC) advises the HDOA Board regarding the future development of Hammock Dunes. In this capacity, the DDC developed a multi-year, time-phased Strategic Growth Plan for Hammock Dunes and, with Board approval, continues to implement key components of this plan.

Current DDC members are: Mike Gill (Chair), Bruce Aiello (HDOA-Treasurer), George Bagnall, George DeGovanni and David Eckert, with Travis Houk (SSMG) providing administrative support.

Recent accomplishments include:

- · Flagler County March 22nd April 20th and May 19th meetings with Administrator Craig Coffey and Commissioner Greg Hansen to understand County Phase I/II Dunes Restoration Plan/Funding and ensure Hammock Dunes is included as part of any County-funded projects.
- · Hosted Joint HDOA/Club meeting with LENNAR Matt Devereaux, Jacksonville Division President and Scott Keiling Director of Land Acquisition/Development to understand LENNAR Plans to build out the 2 remaining condo vacant lots (LENNAR acquired WCI's condo lots). Follow-up with May 26th meeting to discuss conceptual designs. Met June 22nd with the Club to discuss LENNAR concept designs and membership options for condo build-out.
- · Jacksonville meeting on May 2nd with Senator Bill Nelson's (FL US Senator) staff to request his assistance in obtaining FEMA funding reimbursed for HDOA Phase 1 Dunes Restoration.
- · Tallahassee May 23rd meeting with Florida Division of Emergency Management, based on Senator Nelson's congressional inquiry. Petitioned Florida Emergency Management senior leadership team to support HDOA FEMA dollar reimbursement for our Phase 1 Dune Restoration. Meeting resulted in Florida Emergency Management documented support/formal letter to FEMA Atlantic Regional Office recommending FEMA fund HDOA.

It is confusing when the weatherman reports, "Palm Coast received 2 inches of rain today," but your swimming pool has risen less than a 1/4 of an inch and your lawn is crying for water. Obviously, various areas of Palm Coast experience different amounts of rain, wind, etc. The closest weather station to our community is located at the DCDD facility and can be accessed at the website:

There is also a new iphone app called **'Flagler Can'**. The app provides many categories of info for Flagler County, including community events, restaurants, retail shopping, volunteer organizations, clubs, etc. The app is free, so check it out.

**Real Estate** – The following was gathered in recent conversations with local Realtors: Sales of condo units fell below expectations, while sales of single-family homes, below \$700,000 in value, exceeded expectations. One interesting note was the fact that several recent purchasers were represented by out-of-the-area Realtors. This could be the result of the major improvements in both the HDOA's website and the Club's marketing programs, as well as some property listings being included in various MLS sites throughout the state.

**WWTP** - The design of the expansion of the waste water treatment plant is near completion and should be going out for bids in early August. The project will double capacity to a million gallons per day.

**Beach Update** – As of the time of this report, all 'active' walkovers are scheduled to be restored by the end of July. The 2nd phase of the dune and beach restoration project is expected to be completed as a part of Flagler County's county-wide restoration project. The county is in the process of 1) obtaining a permit to work during the turtle season, 2) identifying sources for sand and 3) reissuing the project for bids.

Your HDOA Maintenance Committee has been quite busy since the last issue of *Inside The Gates*. Two of our members – Bill Apsey and Buster Taylor – along with Travis Houk of SSMG have performed day-to-day liaison work, observation and problem-solving on our beach with the dune crossover walkover contractor, Saboungi Construction, Inc. of Ormond Beach. Our Hammock Dunes volunteers have spent hundreds of hours providing this service and deserve thanks from all of us!!

On going concrete curb, sidewalk and perimeter fence repairs continue both for safety and to keep our community looking great.

Island Estates has a new light pole at the Mariners Drive entrance and fresh landscaping at the Main Gate.

The Committee has received proposals for the periodic paving overlay of Camino del Mar and the parking lot at 2 Camino del Mar, which is property of the HDOA. These are being reviewed and prioritized for possible paving this year.

We are in the process of updating the Capital Project's 10-Year Strategic Plan that was prepared two years ago and is a guide to future capital and maintenance projects and their timing and budget costs.

From January 1, 2017 through July 20, 2017, there have been 52 property sales transactions in the Hammock Dunes community. These include 27 single-family homes, 18 condominiums and 7 vacant lots. Currently, there are 8 properties pending or under contract. These include 4 single-family homes and 4 condominiums. As of July 20, 2017, the active MLS listings are the following: 33 single-family homes, 36 condominiums and 39 vacant lots for sale.

### **NESTING SEA TURTLES**




We again are sponsoring 3 nests and the Club has sponsored 3 nests. Marge Rooyakkers will send out notices when the turtle patrol is going to clean out the emerged nests so all can come and watch.

### JUST A REMINDER...

- · It is against the law to touch or disturb nesting sea turtles, hatchlings or their nest.
  - · Avoid using flashlights, lanterns or flash photography while on the beach at night.
- Turn off or shield outdoor lights to prevent lights from shining onto the beach. Lights can misdirect hatchlings and disturb nesting turtles.
- · Fill in holes and knock down sand castles to make the beach safe for the baby turtles.
- · Remove all items, beach chairs, umbrellas and trash from the beach at night. Remove obstacles that a sea turtle can get tangled up in since it could cause injury or death.
