Happy Holidays.

This past quarter has been a busy one for the HDOA, including the beach restoration efforts and rebuilding of the walkovers. Thank you for your patience and

support of both efforts. You will be receiving a separate mailing with a detailed report of the beach restoration project written by David Eckert. The HDOA is continuing to work with the developer and County on the Renaissance project as it moves forward with its plans to bring 28 new homes to our community. HDOA is also working with DCDD on several improvements, including cleaning up the lake adjacent to #7 tee and installation of a new power back-up pumping system. Early next year, the HDOA will begin a phased project to replace our aging light poles. The HDOA is committed to sustaining and

improving service levels and not deferring maintenance.

Starting early next year, the HDOA's newly-formed Strategic Planning Committee will begin its mission of assessing and recommending actions that can enhance the Hammock Dunes community. This will include analysis of strengths and opportunities for improvement and coordination with the County, Club, DCDD, FPL, and others. I am excited about this group and invite your ideas and comments.

In closing, I want to thank each of the HDOA Board members and all of the volunteers who help make Hammock Dunes such a special place to live.



Security and Emergency Response

REMINDER: Please review and update your personnel permanent list with the Gatehouse personnel or online.

Security access control is running smoothly, and as always, we are looking to see if there are new and improved components that we can add, keeping cost in mind.

Please be mindful of front-gating and tail-gating; both have increased in the last month, especially at the North Gate and Mariners Gate.

Keep in mind the gate personnel actions are governed by their Post Orders. For example, if a resident does not have their transponder at a gate, they will have to drive through the guest/vendor side of the gate. A resident must have proper identification with them or access will not be given. Community access without proper identification is not allowed per the Post Orders. Please, as always, be respectful to the gate personal as they are doing their job as instructed per the Post Order's.

Reminders:

Remember when entering Hammock Dunes without a transponder in the visitor/vendor lane, all must show a valid US driver's license before entry is authorized. This includes property owners and Club members that wish to use the visitor's gate.

The August-to-November Committee meetings included approvals of one new home, two major home additions and 25 minor home/landscape changes. An additional three new home designs have been submitted and are at an early stage of review.

DRC procedures are being changed to notify adjacent homeowners that a new home design is under review by DRC. The notification would indicate that the home has received conceptional approval from the Design Review Committee and meets all Hammock Dunes design and setback guidelines. The plans would be available only for viewing by appointment at Southern States Management Group.

The Committee meets during the afternoon of the second Monday of each month. Members include consultants Steve Schuyler and Bob Dickinson, and community members Ada Abernathy, Cosmo DiPerna, Julie Gamble, Julie Karner, Mike Machin, and Donna Trindle. Carsten Georg from Southern States Management Group provides administrative support.

Do you know your Hammock Dunes Protective Covenants, Conditions, & Restrictions? Your Neighborhood Declaration and Bylaws? What about your Design Review Guidelines? Newer residents should make sure they receive these documents from the title company upon closing. Long-time residents probably have them stashed away in an old file cabinet. What is flood insurance, and when do I need it?

Whether or not Flood Insurance is required is determined by the Flood Insurance Rate Maps (FIRMS) published by FEMA and updated on a periodic basis. If you are unsure of whether or not your current or prospective property is in one of the high hazard flood zones, you can very easily find out by consulting the FIRMS online at www.fema.gov. At this site, you can perform a map search by address and can then determine whether or not a property is

located in one of the high flood hazard zones.

We recommend that home owners occasionally check the status of their property, as the FIRMS are updated from time to time. The most recent FIRMS were published as of June of 2018. Here in Flagler County, FL we are aware of numerous numbers of owners being notified by their mortgage company that their property is no longer considered to be in a high hazard flood zone. However, we are also aware of numerous owners being notified that their properties are now considered to be in one of the high flood hazard zones.

Owners of most single family residences have the sole responsibility of providing Flood Insurance for their properties. Many Condominium Associations provide this coverage for their owners through their association dues. If you feel that Flood Insurance is a good idea for you, we recommend that you contact a licensed Insurance Agency to get professional advice about coverages and premium costs.

Turtle News...

Last year we had around 400 nest, but we lost 150 of those to the hurricane, so the net result is about the same number of nests even though we had only half as many laid this year. Hopefully next year will be better.

The 2018 turtle season results: We had 120 nests laid between Jungle Hut and Camptown (Beverly Beach); 74 between Jungle Hut and Washington Oaks. The number of nests varies each year; this year we had approximately half of what we had seen last year. There were 180 loggerhead, 10 green, and 4 leatherback nests. Approximately 70 nests were relocated due to the restructuring of the beach.



A summary of our nests:

- Fs53 evaluated on 8/25 (loggerhead) 100 shells, 1 whole == 101 eggs
 - Fs99 evaluated on 9/18 (loggerhead), 27 live hatchlings, 92 shells, 1 pipped dead, 2 whole == 95 eggs
 - Fs102 evaluated 9/23 (green) 2 live hatchlings, 155 shells, 14 whole == 169 eggs
 - Fs107 evaluated 9/28 (loggerhead) 32 shells, 9 whole == 41 eggs
 - Fs114 evaluated 10/5 (loggerhead) 80 shells, 2 pipped dead, 2 whole == 84 eggs
